

Village Church of Barrington Homeschool Ministries - Waiver of Liability (STUDENT)

Given the COVID-19 environment, the Village Church of Barrington (VCB) is requiring all students participating in homeschool ministry programming to adhere to the following safety guidelines in order to reduce the risk or spread of infection.

Before each homeschool ministry gathering, you will be required to confirm the following:

- My student has not had contact with anyone confirmed with COVID-19 in the past 14 days. (Close contact is considered to be within six feet, for more than fifteen minutes, of an individual who tested positive or who is suspected of having COVID-19.)
- My student has not been outside of the state or country in the last 14 days and been told by a healthcare professional or other health official to self-isolate.
- At any point in the future, if I have reason to believe my student has come into contact with someone with COVID-19, I agree to immediately notify leadership of Classical Consortium Academy (CCA) or Homeschool Enrichment Achieved Respectfully Together (HEART) and keep my student at home. Individuals who have had close contact with a person who has tested positive for COVID-19 or who is suspected of having this infection should isolate at home and monitor symptoms for 14 days.
- My student is not currently experiencing any of the following symptoms:
 - Fever or chills
 - Cough
 - Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
- My student has not experienced any of the above symptoms within the last 14 days.
- At any point in the future, if my student has any of the above symptoms, I will notify CCA or HEART leadership immediately.

I agree to not allow my student to participate in any homeschool programming at VCB with the above symptoms. An individual who has tested positive for COVID-19 or who is suspected of having this infection should seek medical attention, self-isolate, and follow CDC guidelines for discontinuing isolation.

I have read the information above. I agree to adhere to the above safety guidelines as long as my student participates in homeschooling programming at VCB.

IT IS THE RESPONSIBILITY OF THE PARENT/GUARDIAN TO CHECK THEIR STUDENT FOR SYMPTOMS OF COVID-19 PRIOR TO ATTENDING CCA or HEART. CCA and HEART WILL MONITOR STUDENTS DURING PROGRAMMING FOR SYMPTOMS.

Assumption of Risk and Waiver of Liability Relating to COVID-19 (STUDENT)

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. However, there remain many unknowns about COVID-19, how it spreads, and its impact on a student. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending CCA or HEART and that such exposure or infection may result in severe illness, permanent disability, and death. According to the CDC, children with certain pre-existing conditions are at an increased risk of severe illness from COVID-19. The current list of pre-existing conditions is below and continually being updated by the CDC on its website.

Those children who fall into the following categories might be at increased risk for severe illness from COVID-19:

- Those who are medically complex:
 - Those who have serious genetic, neurologic, metabolic disorders, and with congenital (since birth) heart disease
- Similar to adults, children with the following might be at increased risk for severe illness from COVID-19:
 - Obesity
 - Diabetes
 - Asthma and chronic lung disease
 - Immunosuppression

I understand that the risk of becoming exposed to or infected by COVID-19 at CCA or HEART may result from the actions, omissions, or negligence of myself and others, including, but not limited to, CCA, HEART, and VCB employees, contractors, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at VCB homeschool ministries. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Village Church of Barrington, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Village Church of Barrington, its employees, contractors, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any homeschool ministry program.
